Exciting Maryland legislation on climate, environment, and sustainable energy

The Maryland General Assembly is considering several promising bills in 2023. Regional and local action is critical for protecting our environment and limiting climate change. Maryland serves as a model for other states.

Expand Solar Energy in Maryland - Continue the Community Solar Program HB 908 / SB 613

In order to grow our solar capacity, support our sustainable energy efforts, and expand access to affordable solar energy for all Marylanders, Maryland should make permanent the successful Community Solar pilot program.

Save Energy - Shift Buildings From Gas to Electricity through EmPOWER Reform HB 904 / SB 689

EmPOWER Maryland, Maryland's energy efficiency program, needs to be updated so that it focuses on reducing greenhouse gas emissions. The revised program would support switching from fossil fuels to climate friendly, efficient electric heating and appliances. A related bill passed in 2022, but vetoed, would increase EmPOWER support for low- and moderate-income MD households.

Electrify Diesel Trucks and Buses – Protect Our Climate, Protect Our Health HB 230 / SB 224

The Clean Trucks Act will require vehicle manufacturers to sell more zero-emission trucks and school buses in Maryland. Changing from diesel to electric will reduce not only greenhouse gases but also air pollution and related diseases.

Maryland the Beautiful – Protect Our Forests, Farms, and Wildlife Habitats *HB 631 / SB 470*

Protect Maryland's forests, fields, wetlands, and wildlife by providing MD land trusts with the tools to secure available land quickly as well as funds for community stewardship. Land conservation also bolsters our climate change resiliency. This bill establishes goals of protecting 30% of MD lands by 2030 and 40% by 2040.
